TERMS OF USE

Welcome to www.zeemelt.com ("Site") owned and operated by Kyoorius Communications Private Limited ("Kyoorius"). This terms of use sets out the Terms and Conditions for use or access of this Site ("Terms And Conditions") by any individual ("User"). Kyoorius may modify these Terms And Conditions or discontinue the Site at any time without any prior written notice. Any reference to the Terms And Conditions will mean a reference to the Terms And Conditions as amended or modified.

The Site and its contents are designed to comply with the laws and regulations of India. Although accessible in other parts of the world, the Site and its content is intended for access and use by Indian residents only. This Site provides, among other things, information about Kyoorius, its services, people, organization and application process, tools for applicants to submit applications and go through the application process, forums for discussions about topics relevant to start-ups, and profiles of founders and companies who have participated in the event.
